Chapter 4 Financies and Accountability Part 2 Fees [s97]

97 Register of Cost-Recovery Fees

- 1) A local Government may, under a local law or a resolution, fix a cost-recovery fee
- 2) A cost-recovery fee is a fee for
 - a) an application for the issue or renewal of a licence, permit, registration or other approval under a Local Government Act (an application fee); or
 - b) recording a change of ownership of land; or
 - c) giving information kept under a Local Government Act; or
 - d) seizing property or animals under a Local Government Act; or
 - e) the performance of another responsibility imposed on the Local Government under the Building Act or the Plumbing & Drainage Act

ANIMAL CONTROL

Council is committed to promoting responsible pet ownership, making every pet a loved and wanted pet and this fee structure is based on this philosephy From 1 July 2009, the Queensland Government passed new requirements for cat and dog owners.

Quilpie Shire Council is responsible for administering the new requirements, including mandatory:

- *registration of cats
- *microchipping of cats and dogs when sold (seller responsibility)
- *microchipping of cats and dogs when given away (responsibility on the person giving away the animal)
- *microchipping of cats and dogs before reaching the age of 12 weeks
- *tattooing of cats and dogs at the time of desexing
